MEMORANDUM TO THE DIRECTOR

Information: Natural Resources Commission

Subject: Order to Regulate Use; Designate Belle Isle as a Michigan State Park,
Wayne County
Land Use Order of the Director Amendment No. 3 of 2014

Authority:

The Natural Resources and Environmental Protection Act, 1994 PA 451, authorizes the Director to issue orders to designate state parks and recreation areas.

Discussion and Background:

The intent of this order is to:

- Officially designate the leased Belle Isle as a state park "*Belle Isle Park.*"

Belle Isle is a 982-acre island park located in the Detroit River, between the United States mainland and Canada. Since the park's inception in 1879 it has been owned and operated by the City of Detroit. In 1883, the designer of New York City's Central Park, Frederick Law Olmsted, created the master plan for Belle Isle, which transformed this island into a premier park destination for southeast Michigan.

The park is home to the Anna Scripps Whitcomb Conservatory, the Detroit Yacht Club, the Detroit Boat Club, the James Scott Memorial Fountain, the Dossin Great Lakes Museum, the Livingstone Lighthouse, and the Belle Isle Aquarium, among many other significant attractions and natural resources.

In an effort to assist the City of Detroit (City), the Department of Natural Resources (DNR) offered to manage Belle Isle as a state park. A lease was drafted and considered by the City through the Mayor, the Emergency Manager and the City Council. After required steps were followed, the lease was reviewed and on November 12, 2013, the lease was approved by the Emergency Loan Board. The adopted lease is a 30-year lease with the option of two 15-year renewals. The park will remain in the City of Detroit's ownership.

The lease provides for a 90-day transition period, with Belle Isle being officially designated as a leased state park effective February 10, 2014.


The lease agreement also stipulates that the Recreation Passport requirement for Belle Isle is effective February 10, 2014.


Recommendation:

It is recommended that Belle Isle be designated as part of the Michigan state park system as a leased state park and be named "*Belle Isle Park*," to be administered and maintained by the DNR Parks and Recreation Division under the terms of the attached lease.

An additional Land Use Order will follow to amend the state park rules and regulations to ensure they are compatible with the unique uses of the park. These will be reviewed by the Belle Isle Advisory Committee prior to consideration by the Director.

The Michigan State Parks Advisory Committee passed a Resolution in Support of this order at their meeting held on December 12, 2013. This item appeared on the Department's December 2013 calendar and may be eligible for approval on January 9, 2014. The requirement for a Recreation Passport for entry to Belle Isle will be effective February 10, 2014, and dependent upon a vehicle's registration renewal date.



LAND USE ORDERS OF THE DIRECTOR

Amendment No. 3 of 2014

By authority conferred on the Director of the Department of Natural Resources by Section 504 of the Natural Resources Environmental Protection Act, 1994 PA 451, MCL 324.504, and in accordance with R299.921 to R299.933, the Director of the Department of Natural Resources orders the following:

Order 5.16a Entry, use and occupancy of certain state parks, recreation areas and scenic sites, prohibited conduct.

Order 5.16a (1) A person shall not do any of the following:

(a) Enter any of the following state-owned lands with a motor vehicle, unless a valid Michigan recreation passport has been purchased and affixed to the vehicle:


