The purpose of this contract is to replace the existing HVAC distribution system, boilers, partial ceiling and lighting system; perform selective demolition; and add automated controls. The work is needed to replace aged equipment that fails to provide adequate ventilation to alleviate ongoing interior humidity and condensation problems in the building.

AMENDMENTS TO SUB-LEASE FOR STATE LEASED PROPERTY

- 10. DEPARTMENT OF TECHNOLOGY, MANAGEMENT AND BUDGET, GRAND RAPIDS – Amendment Nos: 1-4 to Sub-Lease No. 11194 effective October 1, 2016, through September 30, 2026, with the U.S. General Services Administration,

a Federal Agency, with offices at 230 South Dearborn Street, Suite 3300, Chicago, IL 60604, on behalf of the U.S. Bankruptcy Court for the Western District of Michigan as Sub-Lessee, and the State of Michigan by and for the Department of Technology, Management and Budget as Sub-Lessor, for 50,320 square feet of office space on the second and third floors of the One Division Building, located at 1 Division Avenue North, Grand Rapids, Michigan 49503. The annual rental rate for this Lease Amendment term is \$1,423,376.76 (\$118,614.73 per month). These Sub-Lease Amendments contain no change to Sub-Lease cancellation terms. The Office of the Attorney General has approved these Sub-Lease Amendments as to legal form.

Purpose/Business Case:

These four Sub-Lease Amendments, as prepared and submitted by the federal government, provide for making physical improvements to the sub-leased space at a cost not to exceed \$76,481.69. Principle among these improvements are: installation and wiring of new ingress/egress I.D. card readers, replacement of two water fountains with newer models having more advanced features and replacement of various existing floor coverings with new floor coverings in several parts of the sub-leased premises. As long as the federal government structures its requests for relatively minor physical improvements (like these) as actual amendments to the federal form of lease, the Department of Technology, Management & Budget Real Estate Division has determined it is obliged to submit them for State Administrative Board approval like any other lease amendment to which the state is a party – unless directed otherwise by the AG.

Benefit:

These Sub-Lease Amendments allow the Department of Technology, Management & Budget to make improvements sought by the federal government pursuant to the terms of the existing Sub-lease between the State of Michigan and the U.S. federal government by which the State earns a significant, if not critical, rental income.

Funding:

The building is owned by the City of Grand Rapids. Construction Change Order (CCO) No. 5 to parent Lease No. 10954 between the city and state is the partner mechanism to these Sub-Lease Amendments by which the owner gives its approval for the improvements to be made and facilitates funding thereof. Specifically, CCO No. 5 provided that the City (or its contracted Property Manager) will hire the contractors to do the work specified herein, supervise their work and pay them upon satisfactory completion. The state will reimburse the city. The federal government will reimburse the state.

Commitment Level:

October 1, 2016 through September 30, 2026.

Risk Assessment:

Non-approval of Amendment Nos: 1-4 to Sub-Lease No. 11194 will preclude the department from serving the operational needs of its federal government sub-lessee as required in Sub-Lease No. 11194.

11. DEPARTMENT OF TECHNOLOGY, MANAGEMENT AND BUDGET, GRAND RAPIDS - CCO No. 5 for Lease No. 10954 approved by the State Administrative Board on April 2, 2002, between The City of Grand Rapids, as Lessor, and the State of Michigan by the Department of Technology, Management and Budget. This CCO provides for alterations and upgrades to the space occupied by Sub-Lessee, U.S. Bankruptcy Courts for the Western District of Michigan, located on the second and third floors of the leased premises, including: 1. replacement of selected floor coverings throughout the leased premises, 2. installation of an additional I.D. card reader and running electrical power therefo and 3. installation of two new water fountains. All these improvements are as requested by the Department of Technology, Management and Budget on for its Sub-Lessee at a cost not-to-exceed \$76,481.69, including a 10% cost overrun contingency. The subject space is located on the second and third floors of the One Division Building located at One Division, City of Grand Rapids, County of Kent, 49503.

Purpose/Business Case:

The purpose of this CCO is to make physical improvements to the sub-leased space at One Division as negotiated with the State's Sub-Lessee, U.S. Bankruptcy Courts for the Western District of Michigan, pursuant to Sub-Lease 11194, which was approved by the State Administrative Board on October 25, 2016.

Benefit:

This CCO allows the Department of Technology, Management & Budget to continue to meet the reasonably evolving space use needs of its Sub-Lessee, the U.S. Bankruptcy Courts for the Western District of Michigan, pursuant to Sub-Lease No. 11194.

Source of Funds:

100% Agency Occupancy Fund (Building Occupancy Costs) with reimbursement by the U.S. General Services Administration on behalf of the U.S. Bankruptcy Courts for the Western District of Michigan, pursuant to coming Amendment No. 1 to Sub-Lease No. 11194.

Commitment Level:

Present through September 30, 2028. However, Lease No. 10954 contains a Legislative Restrictive cancellation clause with 60-days' notice.

Risk Assessment:

Non-approval of this CCO will preclude the Department of Technology, Management & Budget from meeting the reasonably evolving space use needs of its Sub-Lessee, the U.S. Bankruptcy Courts for the Western District of Michigan in the One Division Bldg., pursuant to Sub-Lease No. 11194.

ADDENDUM TO LEASE FOR PRIVATE PROPERTY

12. DEPARTMENT OF TECHNOLOGY, MANAGEMENT & BUDGET, LANSING - Addendum No. 1 to Addended and Restated Lease No. 11169 approved by the State Administrative Board on December 8, 2005, between Heart of the City Associates, a Co-Partnership, renamed Heart of the City LLC, 1223 Turner

Street, Suite 300, Lansing, MI 48906, as Lessor, and the State by and for the Department of Management & Budget, renamed the Department of Technology, Management & Budget, for the Department of Civil Service, renamed the Michigan Civil Service Commission, and the Department of Community Health, assigned to the Department of Human Services, renamed the Department of Health and Human Services, as Lessee, for 185,494 square feet of space located at 400 South Pine Street, Lansing, MI 48933. This Addendum provides for reducing the rental rate, modifying the cancellation terms, updating the option to purchase language, and updating lease language as necessary. This Addendum is effective upon obtaining State Administrative Board approval and required signatures and continues to the termination date of the lease, or any extension. The annual per square foot rental rate for this space beginning July 1, 2019, or upon substantial completion, is \$27.43 (\$423,995.13 per month). The per square foot rental rate increases by 2% annually, with the final increase occurring on July 1, 2028 at \$31.15 (\$481,622.04 per month). This rate does not include public utilities. This Addendum contains a Legislative cancellation clause with 60-days' notice. The Attorney General has approved this Addendum as to legal form.

Purpose/Business Case:

The purpose of this Addendum is to reduce the rental rate beginning July 1, 2019, lower the annual rental rate increase, and update the option to purchase language.

Benefit:

The State agencies in this building can remain in a location that meets their business needs, while sharing efficiencies across departments.

Source of Funds:

DTMB: General Fund 37%; Special Revenue Fund 13%; State Restricted Indirect Fund 4%; Internal Service Fund 46%

DHHS: Federal Funds 54.62%; General Fund 45.38%

MCSC: State Restricted 92% (-1%); State Restricted – SSGI 8%

Commitment Level:

Ten years; however, this Addendum contains a Legislative cancellation clause with 60-days' notice.
