However, in keeping with the structure of the original lease. there will be an annual base rent increase of 2.25% starting retro-actively (by one month) on January 1, 2020. The annual per square foot base rental rate for this space beginning January 1, 2020 is \$61.29 (\$11,932.06 per month). Effective January 1, 2021, the annual per square foot base rental rate for this space shall increase 2.25% to \$62.67 (\$12,200.53 per month) and shall increase 2.25% annually thereafter during the extended term of this Lease. The 2.25% base rent multiplier is the same as in the original lease. Base rent does not include annual adjustments for the State's pro-rata share of local property taxes and Lessor's other operating expenses. This is a full-service Lease. This Lease contains an Executive cancellation clause with 180-days' notice. The Attorney General has approved this Addendum as to legal form.

Purpose/Business Case:

The purpose of this Addendum is to provide offices for the Governor's Washington D.C. staff and visiting State of Michigan officials very close to Capitol Hill which best support the State of Michigan's federal government lobbying and consultation initiatives at the U.S. Capitol.

Benefit:

The Hall of the States is ideally located near the U.S. Capitol and legislative offices for purposes of meeting legislators and other issue advocacy partners to advance legislation and regulatory interests of the State of Michigan. This Addendum provides for a one-time Tenant Improvement Allowance from the Sub-Lessor to the State of \$67,744.00.

Engineering, Inc., will provide for asneeded inspection and testing services to be performed for construction projects at various locations in the Cadillac Transportation Service Center service area for the 2020 construction season in Lake, Mecosta, Montcalm, Newago, Osceola, and Wexford Counties. The work items will include inspection; quality assurance testing and reporting; measurement, computation, and documentation of quantities; and closing all project documentation. The contract will be in effect from the date of award through November 15, 2020. The contract amount will be \$678,743.22. Source of Funds: Federal Highway Administration Funds, State Restricted Trunkline Funds, or local funds, depending on the particular project authorized.
- 2. <u>HIGHWAYS Inspection and Testing Services</u>

Contract (2020-0307) between MDOT and L.S. Engineering, Inc., will provide for asneeded inspection and testing services be performed for construction projects at various locations in the Grand Rapids Transportation Service Center service area, in the Grand Region. The work items will include inspection; quality assurance testing and reporting; measurement, computation, and documentation of quantities; and closing all project documentation. The contract will be in effect from the date of award through April 30, 2021. The contract amount will not exceed \$500,252.50. The work items will include owner oversight inspection, owner verification testing and reporting, and determining compliance with the project agreement and associated documentation. The contract will be in effect from the date of award through December 31, 2025. The contract amount will not exceed \$4,195,800. Source of Funds: 100% Windsor-Detroit Bridge Authority Funds.
