INSTRUCTIONS FOR THE SCRAP TIRE MARKET DEVELOPMENT GRANT APPLICATION

Please review the entire Market Development Grant packet including the Introduction and Eligibility Criteria and the Application Process and Evaluation Criteria.

Grant reimbursement is provided through SIGMA, the accounting platform utilized by the State of Michigan. In order to receive grant reimbursement, grant recipients will need to have a SIGMA vendor self-service (SIGMA-VSS) account. EGLE will work with grant recipients to create a SIGMA-VSS account, if an account does not already exist. Applicant must provide contact information (name, phone number and e-mail address) for EGLE to communicate with grant recipients regarding SIGMA accounting and reimbursement. (Consultants may not create a SIGMA-VSS account on behalf of an applicant.)

Governmental entities do not need to include a Michigan Corporate ID Number.

Grants are available to fund three areas of market development:

- Purchase of scrap tires which are used to make another product
- Up to 50 percent of the cost of new equipment
- Up to 50 percent of the cost of new research and development

If you check the “Scrap Tires” box, please complete line 1a and 1b. If you check either the “Equipment” or “Research and Development” box, please see the required application components for information that must be provided.

1. If you are requesting funding for scrap tires, please fill out this section and please read and complete the required application components. If you are not requesting funding for scrap tires, please skip to line 2.
 - a. Enter the amount in Passenger Tire Equivalents (PTEs) or tons of scrap tires to be used or purchased. Please check either PTEs or Tons.
 - 1 PTE = 22.5 pounds
 - Car tires = 1 PTE
 - Semi-truck tires = 5 PTE
 - Oversize tires = 15 PTE
 - b. If you are requesting funding for scrap tires, enter the total amount required to purchase the scrap tires. EGLE will reimburse for the cost of purchasing scrap tires but shall not exceed a reimbursed cost of \$89.00 per ton.
2. Enter the amount requested for either equipment or research and development. Please remember this funding is available for up to 50 percent of the cost of equipment or research and development and requires a 50 percent CASH match.
3. Enter the total amounts requested for scrap tires, equipment, and/or research and development. This is the total grant funding requested from EGLE. (This is a sum of lines 1b and 2.)
4. Enter the total amount of matching funds (should equal or exceed the amount entered in line 3).
5. Enter the total amounts project cost. (This is a sum of lines 3 and 4.)

To be considered complete, an application must include all components listed. Incomplete responses may result in a determination that the application is not eligible for funding. **The Grant application MUST be signed by the Applicant.**
