Search for Combined Sewer Overflow (CSO), Retention Treatment Basin (RTB), and Sanitary Sewer Overflow (SSO) discharge events.
- Site Map Explorer**
Use our mapping tools and advanced search capabilities to navigate all available Water Resources Division public site information.
- Report Spills, Pollution, Unauthorized Activities**

Enter in the code you received to have your user account associated with the site, project or facility you represent.

Add a Site to your account

In order to get started, you'll need to link your account to a regulated business entity (a site, project or facility), or create one if it's not yet in the MiWaters system.



4. Select “Begin Submission”




5. Create a Site

Create a Site Name for the application. Best way to name the site is:

- a. Name of Great Lake: Superior/Michigan/Huron/St.Clair/Erie**
- b. Name of Lighthouse**

Example: Superior – Stannard Rock Lighthouse
