SUBJECT: Report on Wetland Mitigation Bank Funding Program

In accordance with Section 5204f of Part 52, Strategic Water Quality Initiatives, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, attached is the Department of Environment, Great Lakes, and Energy's (EGLE) report on the Wetland Mitigation Bank Funding Program for fiscal year (FY) 2019. To date, 4 grants totaling \$426,172 have been awarded for 150 acres of wetland mitigation bank. These bank sites are being established at Department of Natural Resources state game areas in partnership with the Michigan Municipal Wetland Alliance. These bank sites will provide low-cost mitigation options for municipal projects. No new grants were awarded in FY 2019.

In addition to these wetland banks, there has been a substantial increase in the private banking market in Michigan. There are currently 35 bank sites totaling over 1,700 acres of wetland.

## Legislative Report

### WETLAND MITIGATION BANK FUNDING PROGRAM

Reporting Period: Fiscal Year 2019

Authority: MCL 324.5204f

In accordance with Section 5204f of Part 52, Strategic Water Quality Initiatives, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, the Department of Environment, Great Lakes, and Energy established a Wetland Mitigation Bank Funding Program that provides grants and loans totaling not more than \$10,000,000 to eligible municipalities. Of this amount, up to \$500,000 may be used for grants. Municipalities are required by federal and state laws to mitigate for unavoidable losses to wetland resources. This innovative program provides municipalities with low-cost mitigation options by providing them funding to establish their own wetland bank sites as opposed to purchasing wetland bank credits on the private bank market. The estimated cost savings for municipalities establishing wetland banks under this program is \$70,000 per acre.
