

DWAM Grant Applications Summary

UPDATE: EGLE’s Water Infrastructure Financing Section (WIFS) staff continues to review applications through the projected fundable range of \$36.5 million. EGLE’s Drinking Water and Environmental Health Division (DWEHD) released guidance in March 2021 on [minimum service line material verification requirements](#) as part of the Complete Distribution System Materials Inventory (CDSMI). WIFS and DWEHD are working with each community to adjust their work scopes submitted with the DWAM applications to meet the minimum requirements per EGLE guidance and maximize grant program funding.

WIFS and DWEHD staff are working together to reach out to each fundable applicant to determine eligibility of proposed activities and to ensure proper scoping of DWAM grants. Through these efforts, EGLE has so far been able to extend funding to approximately 20 additional communities than was expected when this list was first published.

While these changes mean more communities are being funded, it is taking longer than expected to meet with each community, receive revised budgets, review those revisions, and execute grant agreements. WIFS staff will be reaching out to applicants directly as we work our way through the list.

Please see below for the priority order list. The dark line on the first page under St. Clair River Water Authority indicates the end of the \$15 million reserved for small communities. At the time of this posting, the Village of Roscommon is the end of the \$36.5 million fundable range. As discussed above, as budgets are revised, additional applications will likely be reached.
