#### 1. Roll Call

Meeting was called to order at 1:05 p.m. Roll call was taken with a quorum present.

#### 2. Approval of Agenda

**Motion:** Dave Maness made a motion to approve the agenda as provided; Dirk Mammen seconded the motion. The motion was approved by all members present.

#### 3. Approval of Minutes from December 19, 2018, Meeting

**Motion:** Mark Henne made a motion to approve the minutes as provided; Dirk Mammen seconded the motion. The motion was approved by all members present.

#### 4. Commission Email Accounts

State email address will be provided to commission members and all commission business should be conducted with the state email addresses.

#### 5. Department of Environment, Great Lakes, and Energy Update

The department has transitioned to the Department of Environment, Great Lakes, and Energy effective April 22, 2019. There is a new <u>MiEnvironment</u> site where the department provides updates, current events, public announcements, and recaps of meetings.

There have not been any permit appeals submitted yet, however, there are processes in place for when appeals are submitted.

#### 6. Michigan Office of Administrative Hearings and Rules (MOAHR) Updates

Julie McMurtry, MOAHR, introduced Susan Maul as the new administrative law specialist. Susan has over 30 years of experience with the department. Susan will assist any three-member panel selected to review potential future appeals.

#### 7. Air Quality Division Permit Overview

Annette Switzer provided an overview of the permits issued by the Air Quality Division (AQD). There are two permitting programs, the New Source Review Permit to Install, which is a construction permit that is required before breaking ground; and the Renewable Operating Permit, which is an operating permit for larger sources.

#### 8. Oil, Gas, and Minerals Division Permit Overview

Adam Wygant provided an overview of the permits issued by the Oil, Gas, and Minerals Division (OGMD). OGMD issues permits under Part 615, Supervisor of Wells, with approximately 70 permits issued annually; Part 625, mineral wells, with 10 or less permits issued per year; Part 631, ferrous mineral mining, with no permits issued in the last several decades; Part 632, non-ferrous metallic mining, with zero to two permits issued annually; Part 635, coal mining, with zero permits issued annually.

#### 9. Materials Management Division Permit Overview

Lonnie Lee provided an overview of the permits issued by the Materials Management Division (MMD). MMD processes approximately ten permits a year under Part 115, solid waste management.

#### **10. Water Resources Division Permit Overview**

Teresa Seidel provided an overview of the permits issued by the Water Resources Division (WRD). WRD issues permits under the Water Quality Protection and the Resources Protection programs. In 2017, WRD issued 4,574 permits for Water Resources; 591 permits for Part 41, wastewater construction; 1,518 for National Pollution Discharge Elimination Systems (NPDES); 155 permits for groundwater; and 1,683 permits for aquatic nuisance control.




