NOTICE OF HEARING

Take notice that an evidentiary hearing will be held before the Supervisor of Wells (Supervisor) in the city of Lansing, Michigan, on the TWENTIETH DAY OF OCTOBER (OCTOBER 20) 2020, BEGINNING AT 9:00 A.M., OTTAWA BUILDING, SECOND FLOOR, 611 W. OTTAWA STREET, LANSING, MICHIGAN 48933. The hearing will be conducted pursuant to Part 615, Supervisor of Wells; of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA), MCL 324.61501 *et seq.*, and the administrative rules, 1996 AACS, 2001 AACS, 2002 AACS, 2015 AACS, 2019 MR 20, R 324.101 *et seq.*; and the Administrative Procedures Act, 1969 PA 306, as amended, MCL 24.201 *et seq.*; MSA 3.560(101) *et seq.* Please note that the Department of Great Lakes, and Energy (EGLE), may change the format and time for this hearing to a virtual hearing, if appropriate, to protect public health due to the current Coronavirus Disease 2019 (COVID-19) risks. EGLE will provide notice of any such change to all individuals who provide a timely answer to the petition as detailed below.

The purpose of this hearing is to consider the petition of Core Energy, LLC (Petitioner), 1011 Noteware Drive, Traverse City, Michigan 49686, requesting an order approving:

The Petitioner requests an order approving an exception to the 80-acre drilling units established by Order 1-73, amended, to form a 160-acre Guelph Dolomite/Ruff Formation drilling unit and statutory pooling all interests into the drilling unit, pursuant to R 324.304. The drilling unit for the proposed Buckhorn 3-23 well consists of the E/2 NE/4 Section 22 and the W/2 NW/4 Section 23, T31N, R1W, North Charlton Township, Otsego County, Michigan.

Take note that if you wish to participate as a party in the hearing by presenting evidence or cross-examining witnesses, you shall deliver to the Petitioner and Supervisor, not less than five (5) days before the hearing date, an answer to the petition in the manner set forth in R 324.1204(6). Proof of mailing or delivering the answer shall be filed with the Supervisor on or before the date of the hearing. The answer shall state with specificity the interested person's position with regard to the petition. Failure to prepare and serve an answer in a timely manner shall preclude you from presenting evidence or cross-examining witnesses at the hearing. If an answer to the petition is not filed, the Supervisor may elect to consider the petition and enter an

order without oral hearing. Mail the answer to the petition to Mr. Kim Sanders at the above address, and to the Supervisor in care of the Assistant Supervisor of Wells, Mr. Adam W. Wygant, EGLE, Oil, Gas, and Minerals Division, P.O. Box 30256, Lansing, Michigan 48909-7756.

Take further note that you may request a change in the location of the hearing to the county in which the proposed drilling unit is located. If the majority of the owners of the oil and gas rights, which are listed in the petition as having not voluntarily pooling their interests into the proposed drilling unit, include in their timely filed answers a request to hold the hearing in the county where the proposed drilling unit is located, the Assistant Supervisor of Wells shall: (i) at the time and place scheduled in this notice adjourn the scheduled hearing; (ii) reschedule the hearing for a location in such county; and (iii) provide, by first-class mail, notice of the rescheduled hearing date, time, and place prior to the rescheduled hearing date to all persons who filed an answer in response to this notice.
