Course sponsors are required to provide you with a Certificate of Completion or other documentation that identifies the following information: course title, EGLE Water Resources Division (WRD) course code number, date completed, and number of credits awarded by category: Technical, Managerial, or Other. If you have taken an approved course during your current renewal cycle and want to receive credit from EGLE, WRD, write in the necessary information below **and attach a copy of your course certificate or other documentation indicating successful course completion. Do this for each course listed.**

If the total number of CECs required to renew your certificate **have not** been met by Municipal Certification Board approved courses, you may be eligible for course credit under the Board’s “blanket approval” provision. Courses may be accepted for certificate renewal under this provision if they are college courses taken for college credit, or training programs offered by the State of Michigan or the U.S. Federal Government, **and** if the training relates to the duties, responsibility, operation, maintenance, or supervision of a sewerage system. List these courses below **and** attach verification of course completion **and** a copy of the course description. EGLE WRD staff will assess whether the training is acceptable for CECs.
