

Reduction of State-Run PODs (Points of Distribution)

Flint Water Quality Update

For over a year Flint's water has been meeting federal standards. The water is now testing at 7 parts per billion (ppb) which is much lower than the federal requirement of 15ppb. Flint's water is one of the most monitored and testing the same as similar cities across the state and country.

Use a filter

Filter use is encouraged while pipe replacement is underway. CORE (Community Outreach and Education) teams are going door-to-door ensuring homes have properly installed and maintained filters, and faucet replacement if needed. Call for CORE at 810-238-6700.

Why are some of the PODs closing?

A partnership between Governor Rick Snyder, Mayor Karen Weaver, Concerned Pastors for Social Action and community leaders, will allow for the continuation of four water sites in each area of the city for the foreseeable future. While water quality has been restored, this helps provide residents additional time to prepare for the ultimate transition to filtered water.
