DECLARATIONS AND AFFIRMATIONS

I, _____, an applicant for the position of Executive Director of the Michigan Gaming Control Board, disclose and affirm the following:

1. I am a resident of the State of Michigan, or, if appointed as Executive Director of the Michigan Gaming Control Board, intend to be a resident of the State of Michigan.
2. If appointed as Executive Director of the Michigan Gaming Control Board I do not intend to hold any other public office for which I would receive compensation other than necessary travel or other incidental expenses.
3. I am of good moral character.
4. I have never been indicted or charged with, convicted of, pled guilty or nolo contendere to, or forfeited bail concerning any felony or misdemeanor involving gambling, theft, dishonesty, or fraud under the laws of this state, or any other state, or the United States, or a local ordinance in any state involving gambling, dishonesty, theft, or fraud that substantially corresponds to a misdemeanor in that state.
5. Neither I nor my spouse, parent, child, child's spouse, sibling, or sibling's spouse hold any direct or indirect interest in, or any employment by a casino enterprise, a person who is licensed to operate a casino under this act or in another jurisdiction, a person who was an initiator of gaming in a city in the State of Michigan, or a person who had an application to operate a casino pending before the Michigan Gaming Control Board, or any other jurisdiction, during the three years immediately preceding my application.
6. Neither I nor my spouse, parent, child, child's spouse, sibling, or sibling's spouse is a member of the board of directors of, or a person financially interested in any person who was an initiator of gaming in a city in the State of Michigan, who is licensed as a casino licensee or casino supplier, or who has an application for a license pending before the Board.
7. If appointed as Executive Director of the Michigan Gaming Control Board, I intend to timely file with the Governor of the State of Michigan under oath, in the manner and form required by statute, a financial disclosure statement listing all of my assets and liabilities, property and business interests and sources of income and affirming my compliance with subsection (10)(a) and (b) of the Michigan Gaming Control and Revenue Act, as amended ("the Act").
8. I do not and if appointed will not hold any direct or indirect interest in, or be employed by, or enter into a contract for services with any applicant, licensee, or registrant under the Act, or a casino enterprise, for a period of four years after the termination of my position with the Michigan Gaming Control Board.
9. I will not represent any person or party, other than the state, before or against the Michigan Gaming Control Board for a period of two years after the termination of my position with the Michigan Gaming Control Board.
10. I understand that any business entity in which I have an interest, or any partner, officer, or employee of that business entity, shall not make any appearance or representation that is prohibited by me under the Act.
11. Neither I nor my spouse, parent, child, child's spouse, sibling, or sibling's spouse have any legal or beneficial interests in any real property that is or that may be directly or indirectly involved with gaming or gaming operations authorized by the Act.
