Nancy Levitt representing the America Massage Therapy Association introduced herself to the Board. She informed the Board she is in favor of the need for more collaboration with the Board.

Sue Bibek, CEO of the Kalamazoo Institute of Massage Education, reiterated the need for more collaboration with the Board. She also informed the Board that her program includes a course on human trafficking.
