The 2018 edition of the Michigan Plumbing Code will be effective September 15, 2021.

The revisions of Chapters 1 and 2 of the 2015 Michigan Residential Code will be effective October 4, 2021.

The Residential and Commercial Provisions of the Michigan Energy Code have been opened.

The Bureau has received considerable feedback regarding referencing the National Electrical Code in the Michigan Residential Code; therefore, leaving the two (2) codes separate to eliminate confusion.
