SB 954 Discussion

Wright explained Senate Bill 954 was approved on January 3, 2017. It will go into effect around April 3, 2017. The bill is known as Public Act 435 of 2016. As a result of the Act, MCL 339.2004 was amended and MCL 339.2005 was repealed. The Act has eliminated the 10 year time frame to take the examination. Applicants can now apply when they are prepared for licensure. The exam applications will be held for one year.

Wright also explained Articles 1 and 2 of the Occupational Code have been revised via Public Act 502 of 2016. The Act sets guidelines for continuing education waiver options as well as enabling the Department to communicate electronically.

Exam Review Discussion

Wright directed the Board to the Michigan Professional Surveyor Exam Development Summary dated 2016 (see Addendum #2). Wright summarized the proposed changes and explained the Board will need to vote to approve the content of the Michigan Professional Surveyor Exam Development Summary dated 2016 as well as the references included.

PROFESSIONAL SURVEYORS – GENERAL RULES

PART 5. CONTINUING EDUCATION

R 339.17505 Continuing education; license renewal; requirements.

- Rule 505.
 - (1) A licensee shall obtain continuing education as specified in R 339.17507.
 - (2) A licensee shall certify the completion of continuing education requirements as a condition for licensure renewal in a format prescribed by the department.
 - The department shall not renew a license if the continuing education requirements have not been completed.
 - (4) A licensee shall submit to the department evidence of fulfillment of the continuing education requirements within
 - 45 days of a request from the department for the evidence to be submitted.

R 339.17506 Acceptable continuing education; limitations. Rule 506.

- (1) Continuing education hours may be acquired in another jurisdiction.
- (2) Continuing education hours shall be relevant to the occupation and may be earned as follows:
 - (a) Successfully completing a college course.
 - (b) Successfully completing a continuing education course.
 - (c) Successfully completing a distance learning course.
 - (d) Presenting or attending a seminar, in-house course, workshop, or professional or technical presentation made at a meeting, convention or conference.
 - (e) Teaching, instructing, or presenting an acceptable course or activity listed in subrule 2(a) to (d) of this rule.
 - Publishing a peer-reviewed paper, article, or book in the licensee's area of professional practice.
 - (g) Serving as a member of the state board of professional surveyors or attending a state board of professional surveyors meeting.
 - (h) Participating in a company sponsored seminar or training that is designed to enhance professional development in the licensee's area of professional practice.
 - Serving as a mentor to a surveying student in a school-sponsored program.
 - Obtaining patents related to surveying.
- (3) Continuing education hours shall be granted once during a renewal period in which the hours were earned for the same course or activity that a licensee completed as either a licensee, instructor, or presenter.
- (4) Continuing education hours shall be granted once for the first time a course is offered or presented provided that the course is not associated with a licensee's regular duties as a member of a faculty.
- (5) Continuing education hours shall not be earned for the following activities:
 - (a) Passing an examination to obtain licensure.
 - (b) Completing a course that does not provide a licensee access to an instructor during the course.
 - Completing a course that is not designed to bring licensees up to date on a particular area of knowledge or (c) skills in the licensee's area of professional practice.
 - (d) Attending a cultural performance, entertainment, or recreational meeting or activity, or participation in a travel group.
- (6) The conversion of other units of credit per renewal cycle shall be as follows:
 - (a) 1 college semester credit hour equals 45 continuing education hours.
 - (b) 1 college quarter credit hour equals 30 continuing education hours.
 - (c) Publishing a peer-reviewed paper, article, or book in the licensee's area of professional practice equals 10 continuing education hours.
 - (d) Serving as a member of the state board of professional surveyors or attending a state board of professional surveyors meeting equals 2 continuing education hours.
 - (e) Serving as a mentor for a surveying student in a school-sponsored program equals 4 continuing education hours.
 - (f) Obtaining patents related to surveying equals 10 continuing education hours.

R 339.17507 Continuing education hours required; renewal.

- Rule 507. Continuing education hours required for renewal shall be as follows:
 - (a) A licensee who holds a license for more than 12 months, but less than 24 months from the date of initial licensure shall obtain 15 hours of continuing education for the first renewal period.
 - A licensee who holds a license for 24 months or more from the date of initial licensure shall obtain 30 hours of (b) continuing education for the renewal period.

R 339.17508 Determination of credit; forms; record keeping.

Rule 508. A licensee shall maintain records of continuing education hours earned for 4 consecutive years. The records (a) The courses or activities completed, the dates when the courses or activities were held and the duration of the courses or activities, the sponsoring organization, the instructor's or speaker's name, and the hours earned.

- (b) Verification of attendance at a course or activity, such as completion certificates or other supporting documentation.

R 339.17509 Auditing. Rule 509. The department may establish a process for auditing licensees regarding continuing education for compliance with the act and these rules.

Summary

An Exam Review Committee (ERC) meeting was held for the Michigan Professional Surveyor licensing exam in December 2016, following a survey-based job analysis study. Meetings began with an online webinar meeting on November 30, and continued with a 2-day meeting at the East Lansing Marriott in East Lansing, Michigan, on December 8 and 9, 2016. A list of participating subject matter experts (SMEs) is provided further in the document.

The goal of the meeting was to:

- Review the results of the Michigan Professional Land Surveyor job analysis
- Update the content outline and test specification based on the results of the job analysis
- Review and confirm that items appearing on the Michigan Professional Surveyor exam are consistent with current rules and regulations
- Update and verify exam reference materials
- · Develop new items to enhance the item bank

It is recommended that new exams be published in June 2017 or another date preferred by the State to reflect content outline and item changes made using the results of the job analysis study and item bank review. This timeline will allow for at least 3-months notifications of exam changes on the PSI website.

In addition, close to 40 new items are being developed by the subject matter expert (SME) panel. New items covering existing exam topic areas will be added in an experimental status once approved by the SME panel. New items representing new content topics will be added to the exam in June 2017 in an experimental status when the exam is updated. Experimental items are presented to candidates during the test administration but do not affect the candidate's score.

This document contains a description of the test development work completed in 2016 and the required next steps.

Job Analysis Overview

PSI conducted a job analysis study for the Michigan Professional Land Surveyor licensing exam. The purpose of the job analysis was to gather the relevant knowledge, skills, and abilities required for proficient practice in the field. The results of the job analysis were used to update the existing exam content specification and to provide a basis for the content validity of the licensing exam in accordance with the Standards for Educational and Psychological Testing and other professional standards.

The job analysis study used a multiple-method approach, incorporating expert judgments of an advisory committee and a state-wide survey of practitioners. The job analysis methodology included initial research, development of a survey, review and editing of the survey by subject matter experts, distribution of the survey using an internet-based survey tool, and analysis of survey results by PSI. A detailed technical report will be provided.

A total of 92 survey responses were completed resulting in a 12.8% response rate. PSI conducted statistical analyses of the responses to determine which of the professional activities and knowledge statements "qualified" for testing on the licensing examinations (i.e., rated as at least moderately important and required at least some competence at the time of licensure).

Webinar Meeting

A three-hour webinar meeting was held on November 30, 2016. The goal of the online meeting was to review and analyze the results of the job analysis survey and to identify appropriate test content areas. Specifically, the subject matter expert committee completed the following tasks:

- 1. Review of the survey respondent demographic data to confirm appropriate representation of the industry
- 2. Review of the professional activity and knowledge statement rating results
- 3. Verification of knowledge and tasks to be covered by the exam

Based on SME feedback, PSI drafted an updated content outline to be reviewed at the on-site meeting.

On-site Meeting

An onsite meeting was held on December 8 and 9, 2016. A subset of items that were not seen during the 2015 exam review meeting, were reviewed as well as items in flagged topic areas that the SME panel considered possibly outdated or affected by recent legislative changes, including the Corner Recordation Act. The SME committee reviewed 127 items, of which 83 were approved without changes, 17 were edited, 23 were deleted, and 7 where placed on a hold status for further review.

Following the item review, the SME panel reviewed and finalized the exam content outline. Subtopics Corporations & Partnerships, Control documents, and Magnetic declination were deleted from the exam



content outline based on job analysis results and SME judgement. In addition, the following topics were added to the exam content outline: *Highways and Private Roads Act, Records of United States Land Office Act, United States Field Notes, Maps, Plats, and Records, Uniform Electronic Transmission Act, Office management and practice, Prorate, Calculated Culvert, and Unmanned aerial vehicles.* Numbers of items per topic were also adjusted for two topic areas.

The SME-confirmed content outline and reference list can be found at the end of the summary document, along with the meeting agenda and list of participating subject matter experts.

New Item Development

PSI reviewed the item bank and determined areas for new item writing. SMEs were trained for item writing and assignments were given in new areas as well as areas of shallow coverage. SMEs are currently completing their item writing assignments. The goal is to have all item writing complete by January 31, 2017.

Close to 40 new items are being developed by the SME panel. New items covering existing exam topic areas will be added to the exam in an experimental status once approved by the SME panel. New items representing new topics areas added with the completion of the job analysis will be added to the exam in June 2017 in an experimental status. Experimental items are presented to candidates during the test administration but do not affect the candidate's score.

A second item review will be conducted to collectively review and approve any new items for the exam.

Next Steps

The next step will be for the State to review and approve, if satisfactory, the new content outline. Once approved, the exam publication date will be confirmed and new exam changes will be posted to the PSI website. It is recommended that new exams be published in June 2017 or another date preferred by the State. This timeline will allow for at least 3-months notifications of exam changes on the PSI website and updating of the Candidate Information Bulletin.
