Rochester College: The program is moving NUR 2203 Integrated Pathophysiology from the sophomore Fall semester to the sophomore Spring semester in the program curriculum sequence. The submission is noted.

Schoolcraft College: The program is decreasing the credits for the program from 67.5 to 63.5 due to the elimination of a biology department requirement. Further the program is moving MATH 113 to the prerequisite semester instead of required completion of the course by the end of the ADN program. Lastly, there is a revision on several nursing course syllabi to reflect courses required prior to subsequent courses. The submission is noted.

South University: The program is requesting a temporary increase of 4 additional seats. Currently they are allowed 24 seats. Additionally, the program is requesting to change the 2 credit course NSG4069 (Caring for Diverse and Vulnerable Populations II) from a Pass/Fail course to a graded course to align with the curriculum of all other South University Nursing Programs in the United States. The Michigan Department of Health and Human Services (MDHHS), Office of Nursing Policy (ONP), has been busy working on behalf of nurses in the state of Michigan.

Online Transition to Practice

The first two online transition to practice modules, Communication in Healthcare and Safety in Healthcare were completed and are now available to Michigan's Nurses. The third module, Evidenced-Based Practice, is anticipated later in 2017.

The goals of these courses are to:

- 1. improve retention of new nurses;
- improve patient safety by assisting new nurses in transitioning from task orientation to critical thinking; and
- increase new nurses' comfort level with prioritizing care and applying the techniques introduced in their educational programs.

Participants successfully completing each module may choose to earn free continuing education units (CEU).

Pilot Nursing Clinical Placements

Undergraduate student nurses have completed the first semester of new clinical placements at two head start sites in Flint and performing education and outreach for the Latino Community at a Federally Qualified Health Center and in coordination with the community group "Latinos United for Flint." Nurse practitioner students have completed clinical placements at a Federally Qualified Health Center. Michigan Public Health Institute is in the process of collecting data about the first semester experiences for the evaluation of the impact of the placements on the sites and the ability of the placements to provide educational experiences that meet the learning objectives of the student nurses. Outreach with additional sites is anticipated to yield additional clinical placements in 2017.
