Carpenter explained that House Bill 5326 is one of the items awaiting Governor Snyder's signature. The bill provides that the continuing education rules for veterinarians and vet techs are effective January 1, 2020. Carpenter presented draft language for the new proposed rule changes which provide for continuing education that can begin promulgation once the other changes are final.
