**ADMINISTRATIVE ORDER NO. 2013-02**  
**SPIRIT PRODUCT DISTRIBUTION REQUEST**

Luxco, Inc. (vendor of spirits), at the above-noted location, has acquired several brands of spirits from Jim Beam Brands Co. (vendor of spirits). The brands involved are Bellows rum, gin, and scotch, Calvert gin, Calvert Extra, Lord Calvert Canadian whiskey, Canada House whiskey, and Wolfschmidt vodka. Luxco, Inc., a vendor of spirits, has an existing written agreement or contract with an Authorized Distribution Agent (ADA). Luxco, Inc. has submitted a written request for permission to distribute these new brands through their existing ADA, General Wine and Liquor Company, Inc., effective April 28, 2013.

Under Article IV, Section 40, of the Constitution of Michigan (1963), the Commission shall exercise complete control of the alcoholic beverage traffic within this state, including the retail sales thereof, subject to statutory limitations. MCL 436.1201(2) provides the

Commission with the sole right, power, and duty to control the alcoholic beverage traffic and traffic in other alcoholic liquor within this state, including the manufacture, importation, possession, transportation and sale thereof.

After reviewing the request and discussion of the issue at the meeting, the Commission finds that based on the information received this request should be approved.

THEREFORE, IT IS ORDERED that:

- A. The request made by Luxco, Inc. to distribute the Bellows rum, gin, and scotch, Calvert gin, Calvert Extra, Lord Calvert Canadian whiskey, Canada House whiskey, and Wolfschmidt vodka brands through General Wine and Liquor Company, Inc. effective April 28, 2013 is hereby APPROVED.
- B. Luxco, Inc. and General Wine and Liquor Company, Inc. shall submit an executed Addendum to Schedule A of the ADA contract by February 15, 2013 to prevent delays for these product brands.
- C. Luxco, Inc. shall file the appropriate product changes in the Commission's E-Quote system by February 15, 2013 to prevent delays for these product brands.
