ADEX Board of Directors

- Adopted a new ADEX Mission Statement.
"Develop clinical licensure examinations for dental professionals"
- Appointed Ms. Pat Connolly-Atkins, RDH, MA as the new Dental Hygiene Examination Chair.

Changes to the ADEX Dental Examination:

- Made changes which allow the "Buffalo Model" CIF format to be delivered this year at schools who request it. This will be at CDCA sites this year with CITA's future use to be determined after further study of the logistics.
- Developed a procedure by which a candidate can perform an "Indirect Pulp Cap", where indicated, starting with the 2017 Examination.

Changes to the ADEX Dental Hygiene Examination:

- Extended the Examination time from 90 minutes to 120 minutes
- Manual revisions in multiple area to improve the clarity of information to candidates.
- Definition of calculus in the detection exercise redefined.
- Changes to the scoring rubric and point values for the 2017 Examination Cycle.
- No major changes in the content or criteria of the examination.

ADEX House of Representatives:

- Approved Bylaw changes that will change the membership of the House of Representatives and developed bylaws concerning a conflict of interest.
- Approved the Dental and Dental Hygiene Examinations as recommended by the Examination Committees and the Board of Directors.

PATIENT CENTERED CURRICULUM INTEGRATED FORMAT EXAM

Formally know as "Buffalo Model"

- 1) represents the patients*
 - 2) competence vs performance*
 - 3) independent third party that done anonymously.*
 - 4) ADA ethical concerns addressed*
 - 5) no more reimbursements to patients for exams*
 - 2) no more patient brokering*
 - 3) no more delaying treatment for the exam*
 - 4) no remuneration for acquiring patients between candidates*
 - 5) have follow up*
 - 6) eliminates unnecessary tx of incipient caries*
 - 7) informed consent*

Dental Examination

Moving towards a pass / fail exam 2017 goal

Endodontic exam

- 1) No subs pass or fail
- 2) Height of the oblique ridge is the measuring criteria for the posterior access opening
- 3) Overfill is a failure
- 4) Manual changes: only pink gutta percha, use of thermal gutta percha can be used, but use at own peril, tooth fracture vs crown fracture.

Periodontal Exam

- 1) No changes to the 2016 exam

Prosthetic Exam

- 1) The changes for grading were very complex, any changes were tabled

Restorative Exam

- 1) Grading, no subs in restorations acceptable/critically deficient.
 - 2) For preparations 3 substandard in 3 different axis-over-prepped is CD
 - 3) Adding the word flash to criteria of margin excess/deficiency
 - 4) Allow patients with latex allergy in latex free areas
 - 5) Addition of the indirect pulp cap
 - 6) All anterior preparations are lingual access, unless a buccal access is clinically justified
 - 7) Candidates may submit an intra-oral picture
 - 8) Indirect pulp cap procedure added
 - 9) All preps need to be at acceptable criteria before a modification request is submitted. 10 point penalty 2017
 - 10) TABELLED -20 point penalty for request to remove decay, when no decay present—unjustified modification request
 - 11) A posterior box that is over 2mm on occl
 - 12) 2usal is a CD
 - 13) Gingival floor not broken in an Amalgam preparation is CD

Dental Hygiene Exam

- 1) Not a lot of changes to the 2016 exam
 - 2) The electronic scoring format pilot was a success of 333 candidates 92% pass rate
Those that took it a second time passed.
 - 3) The 8 points for radiographs has been removed . Radiographs have been placed in
Diagnosis for eligibility. Move the scoring points into calculus removal . 70%
 - 4) 2016 the exam time will be increased to 2 hours.
