# **Proposal for Telehealth (SB 0753)**

The Telehealth bill passed requiring signed consent for Telehealth treatment.

# Occupational Noise Exposure Regulation

The new MI OSHA regulation made tables current and didn't change.

# Rules Update – Requirement for Pain and Symptom Management

Leary informed the Board the statute requires continuing education in Pain and Symptom Management for all health professionals. Leary recommends opening the rules to add this requirement.

# **Human Trafficking Requirement**

Leary informed the Board that the rule for training in identifying victims of human trafficking was finalized. This is a one-time training requirement.
