## **COMMITTEE REPORTS**

#### **Veterinary Technician Exam Committee**

Lucinda Clark introduced Joe Powell, who is the new Testing Analyst for the Licensing Division.

Clark provided the statistics of the 2014 Veterinary Technician Exam:

- 248 candidates sat for the Exam
- 200 passed the Exam, which is a 80%passing rate

Clark noted that the Department is currently in the process of contacting those candidates by mail who failed the 2014 Veterinary Technician Exam regarding retesting.

#### **Health Professional Recovery Committee (HPRC) Nomination**

Lind referenced a Memorandum dated March 4, 2015 from Susan M. Bushong, Contract Administrator for the Health Professional Recovery Program (HPRP).

MOTION by Bell, seconded by Thorp-Stout, to appoint Katherine Donahue, D.V.M. as the HPRP representative for the Board of Veterinary Medicine, to fill a partial-term expiring on December 31, 2016.

#### Administrative Rules amendments

Siracuse explained that under the "Principles of Veterinary Medical Ethics of the American Veterinary Medical Association (AVMA)," a veterinarian shall provide veterinary medical clinical care under the terms of a veterinarian-client-patient-relationship (V.C.P.R.). Further, it is unethical practice to prescribe medications to a patient without an examination. He and the Rules Subcommittee will be drafting amendments to the Administrative Rules regarding V.C.P.R. rules. Siracuse distributed a document to Board members entitled Bureau of Health Care Services Compounding Pharmacy Law FAQ. Additionally, Siracuse researched and addressed questions that were asked by Board members at the December 18, 2014 meeting regarding the new pharmacy compounding laws and the legality of third party dispensing. The questions and findings are noted as follows:

Question 1 – If and how do the new laws regarding compounding affect veterinarians?

Answer – Compounding laws do not apply to veterinarians or veterinarian practices. No pharmacy license is required to compound in office. Veterinarians are not required to have a Pharmacist in Charge (PIC).

Question 2 – Can a veterinarian dispense medication without seeing the patient?

Answer – No, but veterinarians are free to sell medications to each other.

Board members are encouraged to share this information with their professional associations.

Siracuse noted that the Chair of the Rules Subcommittee will direct when and where the meetings will be held. Email conversation is also considered a meeting.

#### **Department Update**

Lind announced that the Bureau will be reorganized during 2015 to combine regulation of the health professions specified in the Public Health Code with the occupations specified by the Occupational Code (i.e. accountants, realtors, cosmetologists, etc.).

## **PUBLIC COMMENT**

An attorney commented on her experience with open meetings and open records. She spoke to the proper standard of care issue, and was asked to desist from going any further by Hudson, as her comments could harm the due process rights of Michigan licensees. She is curious why Rule R 338.3801 was rescinded on March 12, 2015. She believes public comment should be heard prior to the Board's decision regarding a complaint against a licensee.

Chris Patterson explained his view of the disciplinary process once an allegation is filed with the Department.

A gentleman asked a question why the rule was rescinded and the procedure was changed.

Charles Pol expressed that he believes there is a fundamental flaw in procedures. He thinks it is a dereliction of duty for the state to not post standards of care and changes thereto. Animal owners have a right to be a part of this discussion, and therefore should be able to be heard before the board votes on a licensee's case.
