Respondent must petition for reclassification of the license. Respondent will be placed on probation to run concurrent with the limited license. Probation terms are quarterly supervisor reports, and continuing education, pre-approved by the Board chair or designee, to include: 20 hours in the area of orthopedic surgery, with a minimum of 8 of the 20 hours in a wet lab setting; 5 hours in the area of general surgery; and a minimum of one 8 hour course in the area of ethics. Respondent will be automatically discharged from probation upon reclassification of the limited license. After consideration of Michigan Administrative Code R 338.7005, Respondent is fined \$1,000.00 to be paid within 60 days.
