If within six months the Department has received satisfactory evidence from the HPRP either verifying that Respondent has undergone an evaluation, has entered into a disciplinary, non-confidential regulatory monitoring agreement and that the HPRP has endorsed Respondent as safe to practice, or that the HPRP has determined that Respondent does not require treatment monitoring, Respondent's license shall automatically be reinstated. Upon reinstatement, Respondent's license shall be limited for a minimum of one year. Terms of the limitation preclude Respondent from owning and investing in any pharmacy, and holding a position as the pharmacist-in-charge. Respondent is required to petition for reclassification. Upon reinstatement, Respondent is placed on probation to run concurrent with the period of limitation with required quarterly employer reports and comply with the terms of an HPRP monitoring agreement, if applicable. If license remains suspended for more than six months, Respondent shall petition for reinstatement.
