MICHIGAN BOARD OF COSMETOLOGY RULES COMMITTEE WORK GROUP MEETING MINUTES

APRIL 23, 2020

The Michigan Board of Cosmetology, Rules Work Group, met on April 23, 2020. The meeting was held via Zoom, pursuant to Executive Order 2020-48.

CALL TO ORDER

Linda Ward, Chairperson, called the meeting to order at 2:00 p.m.

ATTENDANCE

RULES DISCUSSION – A copy of the current rules is attached to this document.

Marks explained the timeline and process for rule promulgation. Marks reminded the public that this meeting was set to review the comments received from the public hearing and that the Rules Committee will make the final recommendation on the proposed rule changes to the Board.

Rule 338.2161 Cosmetology Curriculum

Comment made at hearing: The commenter stated that artificial nails were rarely used in the industry and requested that the term "artificial nails" be changed to gel nail application because this has largely replaced acrylic nails. Ward stated that the term "artificial" can mean gel, acrylic, powder, etc., and allows for open interpretation.

Weaver agreed with Ward and stated that the term allowed for new technology.

Wilkinson agreed as it was all encompassing.

The Rules Committee agreed that no changes were necessary to this proposed rule.

Rule 338.2169a Cosmetologist, esthetician, electrologist, manicurist, and natural hair culturist curriculum

Comment made at hearing: The commenter stated that the increased hours in esthetics and manicuring services was not warranted because most students were focused on hair care services.

Ward stated that these hours are sufficient.

Weaver agreed and stated that it allowed a licensee to transfer.

Wilkinson agreed.

Rule 338.2169a Cosmetologist, esthetician, electrologist, manicurist, and natural hair culturist curriculum

Comment made at hearing: The commenter stated that the omission of minimum practical applications should be restored to ensure that each student has a basic working knowledge of all areas.

Table 11

Marks stated that the minimum practical applications should be included based on statute.

Weaver expressed concern with how to track applications.

Marks stated it was a statutory requirement.

Weaver stated schools currently do not track this.

Marks stated the rules must provide the minimum practical applications.

Weaver said they can track hours but not applications.

Wilkinson explained that it would be different for everyone because education is individualized.

Weaver recommended matching applications to hours.

Ward was in support of that idea because she did not want confusion among licensees.

Sager questioned if there would be a way to combine hours.

Marks stated that statute did not allow a combination of the minimum practical applications with practical application hours.

Ward stated it will be easier to keep separate.

Discussion was held.

Weaver recommended matching practical and application hours.

Ward recommended not to break down services and simply provide a total number of services.

Wilkinson agreed.

The Rules Committee agreed that subsection(b) should total 425.

Marks inquired about subsection (c).

Weaver suggested to leave 50 as the minimum.

Wilkinson agreed.

Pavlik stated that 50 was too high as estheticians have a different number of hours to complete.

Weaver suggested reducing the amount to 25.

Both Wilkinson and Ward agreed with Weaver.

The Rules Committee agreed that both subsections (c) and (d) should be 25 hours.

Kolar stated lowering the number impacts more.

Weaver stated it was just a minimum and it could be exceeded.

Table 12

Marks requested that the Committee provide her with the number of hours they would like to see students meet.

Weaver stated he could not give insight because he was not too familiar with those applications.

Marks stated the 150 minimal applications came from the current requirements.

The Rules Committee agreed to leave the 150 minimal applications.

Weaver suggested to leave the 50 hours.

The Rules Committee agreed.

Table 14

Weaver suggested to leave the 50 hours.

The Rules Committee agreed.

Table 15

Ward stated that subsection (a) should say electrology instead of natural hair.

Marks stated she will correct the table.

Weaver suggested to leave at 40.

The Rules Committee agreed.

Rule 338.2169b Cosmetologist instructor and cosmetologist limited instructor curriculum; electrologist instructor, limited electrologist instructor, and limited specialist instructor curriculum.

Comment made at hearing: The commenter stated that the omission of minimum practical applications should be restored to ensure that each student has a basic working knowledge of all areas.

Table 16

Marks stated that it is currently 150 and it was changed to 120 to match the hours.

Weaver suggested lowering subsection (d) to 10.

The Rules Committee agreed.

Weaver suggested reducing subsections (a) and (c) to 20 and leave subsection (e) at 40.

The Rules Committee agreed.

Table 17

Weaver suggested to leave it as is.

Marks stated subsection (a) = 10, subsection (c) = 20, subsection (d) = 10, and subsection (e) = 40.

Pavlik stated that the two categories should match and be reduced due to the total number of hours being different.

Ward suggested that subsection (e) should be 15.

The Rules Committee agreed.

Proposed New Rule. Licensure of Nail Technician

Comment made at hearing: The commenter stated that the board should consider approving instruction for nail technicians from a nail technician school and not require that instruction to be offered by a cosmetology school.

Ward advised that no changes were necessary.

Marks stated the statute does not permit it.

The Rules Committee agreed that no changes were necessary.

Smith inquired about the current pandemic.

Marks stated this was not the place to discuss that matter as the meeting was for the comments made on the draft rules at the public hearing.
