Chair Report

Drewyor notified the Board that the NCEES Central Zone Meeting is the week of May 15, 2017. Drewyor and Michalski-Wallace are attending the meeting.

Drewyor then explained that the annual NCEES meeting will be August 22, 2017 through August 26, 2017 in Miami Florida. He requested that Board members interested in attending the annual meeting to notify him six to eight weeks prior to the meeting. Drewyor is interested in attending the meeting.

Drewyor provided an update regarding education at Michigan Technological University where Drewyor teaches. There is an open faculty position. 45 candidates have applied. 22 students are enrolled in the TwiST summer program.

Drewyor communicated his desire to form a new subcommittee focusing on education standards.

Gravlin added to Drewyor's thoughts by expressing that it is becoming difficult to fill vacancies in the profession that require technological background because the profession is competing with specialized IT positions that offer higher salaries.

Drewyor formed the Educational Standards Subcommittee. Drewyor appointed Barish, Bartlett, Hertrich, and himself to the committee.

Department Update

Wright provided licensing statistic information as follows:

There are 854 active Professional Surveyor licenses in the State. Of those, 460 will be up for renewal in October 2017. This a drop in licenses from August of 2016, there were 915 active licenses. Wright stated that 75% of the licensees are Michigan residents.

Wright also notified the Board that there are currently five complaints being handled by the Continuing Education Audit Team.

Hitzler notified the Board of two staffing changes. Cheryl Pezon, JD, is no longer the manager of the Boards and Committees Section. Pezon is now the Deputy Director of the Bureau of Professional Licensing. Kerry Przybylo, JD, is now the Manager of the Boards and Committees Section.
