After consideration of Michigan Administrative Code, R 338.7005, Respondent is fined \$1,000.00. If license is suspended longer than six months, Respondent must apply for reinstatement. Upon automatic reinstatement, Respondent's license will be limited for one year with practice only under the general supervision of the approved supervisor. The limitation shall only be reduced while employed as a psychologist. Respondent is placed on probation to run concurrent with the limitation with quarterly supervisor reports and completion of 15 hours of pre-approved continuing education in the areas of boundary violations and ethics, which will not count toward license renewal. Failure to comply with terms and conditions of limitation or probation, license shall result in a minimum one-day suspension of the license.
