Nursing home antibiotic stewardship refers to coordinated efforts to promote appropriate prescribing of antibiotics for patients in long-term care facilities. Regardless of the clinical setting, the goal is to promote adherence to clinical practice guidelines to provide the best standard of care and to minimize the spread of antibiotic-resistant bacteria.
