1. Moved by Commissioner Quimby, supported by Chairman Deloney, that the minutes of the Southfield Appeal Hearings of January 17, 2013, be approved as written and presented, motion carried by unanimous vote.
2. Hari's Party Store, Inc., 417 Shattuck, Saginaw, Carrollton Township, Saginaw County Request ID# 629110

The licensing hearing was conducted for Hari's Party Store, Inc., Request ID# 629110. Linda Pytel-McDowell appeared on behalf of the Attorney General's Office, Attorney Thomas J. Giachino and applicant stockholder, Arvinder Pal Singh, appeared on behalf of the applicant. Ms. Pytel-McDowell, Mr. Giachino and Mr. Singh offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated December 5, 2012, and approve the request as set forth in the Licensing Appeal Order, to transfer all stock interest in 2012 Specially Designated Distributor and Specially Designated Merchant licensed business with Sunday Sales Permit (P.M.) and Sunday Sales Permit (A.M.). Commissioner Quimby supported, and the motion was carried by unanimous vote.
