2. SGNJ, LLC, 1603 NE Diamond, Grand Rapids, Kent County Request ID# 618283

The licensing hearing was conducted for SGNJ, LLC, Request ID# 618283. Jason Geissler appeared on behalf of the Attorney Generals Office, Attorney Douglas Mileski and Charanvir Singh, member, appeared on behalf of the applicant, and Det. Maureen O'Brien of the Grand Rapids Police Department was present. Mr. Geissler, Mr. Mileski, Mr. Singh and Det. O'Brien offered comments regarding this case. After discussion on the record, it was moved by Chairman Deloney to affirm the Commission Order dated November 23, 2011, denying the request to transfer ownership of 2011 Specially Designated Merchant license from Lexa's Grocery, LLC. Jason Geissler appeared on behalf of the Attorney Generals Office and Attorney Kent Bieberich appeared on behalf of the applicant. Mr. Geissler and Mr. Bieberich offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order dated November 23, 2011, and to approve the transfer ownership of escrowed 2011 Specially Designated Distributor and Specially Designated Merchant licenses with

Sunday Sales Permit (PM) from Wac-N-Pac Corporation and the applicant's spouse, Palwinder Singh Bath, be prohibited from working at or managing the business until the Commission has received proof of completion of an approved Alcohol Management training course.
