The penalty hearing was conducted for ACY Restaurants, LLC, Business ID# 222048. Susan Moody appeared on behalf of the Attorney Generals Office and Attorney Terrance Colin appeared on behalf of the licensee. Ms. Moody and Mr. Colin offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to suspend the license for fifteen (15) consecutive days as set forth in the Penalty Hearing Order, with the suspension to be served from Friday, February 22 through Friday, March 8, 2013.
