Chairman Deloney called the hearings to order at 10:13 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Commissioner Quimby, that the minutes of the Lansing Appeal Hearings of January 29, 2013, be approved as written and presented, motion carried by unanimous vote.
2. Chairman Deloney advised that the hearings for Chequers of Saugatuck, Inc., Complaint No. 2-150770, and Toulouse, Inc., Complaint No. 2-150771, were scheduled for today's hearings and were postponed.
3. Mr. Z Enterprises, Inc., d/b/a Cruisers Pub, 7638-7640 S Westnedge, Portage, Kalamazoo County Business ID# 144550

The penalty hearing was conducted for Mr. Z Enterprises, Inc., Business ID# 144550. Jason Geissler appeared on behalf of the Attorney General's Office and no one was present for the licensee. Mr. Geissler offered comments regarding this case. After discussion on the record, Chairman Deloney advised the findings of the Commission are that the Licensee has a history of similar violations prior to the violations that warranted the penalty hearing, that three of the four violations from the penalty hearing were sales to intoxicated patrons that included damages to public buildings, home invasions and fights. Motion made by Chairman Deloney that the licenses remain in escrow until transferred and orders a 20 day suspension starting Wednesday, February 6, 2013, as set forth in the Penalty Hearing Order. Supported by Commissioner Quimby, the motion was carried by unanimous vote.

4. Avajor, Inc., 501 W Ganson, Jackson, Jackson County      RID# 670507

The licensing hearing was conducted for Avajor, Inc., Request ID# 670507. Jason Geissler appeared on behalf of the Attorney Generals Office, Attorney Joseph Shallal and stockholder Adam Cyrocki, appeared for the applicant. Mr. Geissler, Mr. Shallal and Mr. Cyrocki offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated December 27, 2012, and to approve the request as set forth in the Licensing Appeal Order, to transfer ownership of the 2012 Specially Designated Merchant license with Sunday Sales Permit (A.M.) and permission for one (1) Direct Connection, from 501 W. Ganson, Inc. Supported by Commissioner Quimby, the motion was carried by unanimous vote.

With no further business, moved by Commissioner Olshove, supported by Commissioner Quimby, that the Appeal Hearings be adjourned at 10:33 a.m., motion carried by unanimous vote.
