Chairman Deloney called the hearings to order at 10:16 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Chairman Deloney, that the minutes of the Lansing Appeal Hearings of March 12, 2013, be approved as written and presented, motion carried by unanimous vote.
2. Mappco, LLC, 3112 S Ninth, Oshtemo, Oshtemo Township, Kalamazoo County Request ID# 672825

The licensing hearing was conducted for Mappco, LLC, Request ID# 672825. Dawn Hetzel appeared on behalf of the Attorney Generals Office, Attorney Gary Tibble and member Emilio Dacoba, appeared on behalf of the applicant. Ms. Hetzel and Mr. Tibble offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated February 20, 2013, and to approve the request as set forth in the Licensing Appeal Order, to transfer ownership of escrowed 2012 Class C and Specially Designated Merchant licenses from Mi Ranchito Restaurants, Inc. Commissioner Olshove supported, and the motion was carried by unanimous vote.

3. Gilligan-Steele Tasting LLC, 432 E Paterson, North Building, Ste 2000, Kalamazoo, Kalamazoo County Request ID# 663152

After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated March 6, 2013, and to approve the request as set forth in the Licensing Appeal Order, for a new Micro Brewer License. Commissioner Olshove supported, and the motion was carried by unanimous vote.

4. SPS Superior Professional Services, LLC, 100 Monroe, Kalamazoo, Kalamazoo County Request ID# 628515

The licensing hearing was conducted for SPS Superior Professional Services, LLC, Request ID# 628515. Dawn Hetzel appeared on behalf of the Attorney Generals Office, Attorney Nicholas A. Vlachos and member Francois Moyet, appeared on behalf of the applicant. Ms. Hetzel and Mr. Vlachos offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated February 6, 2013, and to approve the request as set forth in the Licensing Appeal Order, to transfer ownership of escrowed 2012 Class C license from Lone Star Steakhouse & Saloon of Michigan, Inc. and transfer location (governmental unit) from 2255 Tittabawassee, Saginaw Township, Saginaw County. Commissioner Olshove supported, and the motion was carried by unanimous vote.

Ms. Hetzel and Mr. Hoogeboom offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated February 6, 2013, and to approve the request as set forth in the Licensing Appeal Order, to transfer ownership of 2012 Specially Designated Distributor and Specially Designated Merchant licenses from Miss Tracy Inc., of Grand Rapids. Commissioner Olshove supported, and the motion was carried by unanimous vote.

With no further business, moved by Commissioner Olshove, supported by Chairman Deloney, that the Appeal Hearings be adjourned at 12:08 p.m., motion carried by unanimous vote.
