Chairman Deloney called the hearings to order at 10:13 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Commissioner Quimby, that the minutes of the Lansing Appeal Hearings of March 19, 2013, be approved as written and presented, motion carried by unanimous vote.
2. The hearing for Irene M. Perez, Request ID# 664680, scheduled for today, has been postponed.
3. S.J.H. Agency, Inc., 3311 W Carleton, Hillsdale, Hillsdale County  
Request ID# 623632

The licensing hearing was conducted for S.J.H. Agency, Inc., Request ID# 623632, which was tabled from January 8, 2013. Jason Geissler appeared on behalf of the Attorney Generals Office, Attorney David Lee Taylor and applicant stockholder David Gadelkarim, appeared on behalf of the licensee. Mr. Geissler and Mr. Taylor offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to affirm the previous Commission Order of denial dated November 28, 2012, and to deny the request as set forth in the Licensing Appeal Order, to transfer all stock in the 2012 Specially Designated Merchant license from Sally J. Hawkins. Commissioner Olshove supported, and the motion was carried by unanimous vote.

4. DSKO, Inc., 242 E Kalamazoo, Ste 101, Kalamazoo, Kalamazoo County  
Request ID# 668302

The licensing hearing was conducted for DSKO, Inc., Request ID# 668302. Jason Geissler appeared on behalf of the Attorney Generals Office, Attorney Owen Ramey and sole stockholder Deok Soon Ko, appeared on behalf of the applicant. Mr. Geissler and Mr. Ramey offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated January 30, 2013, and to approve the request as set forth in the Licensing Appeal Order, to transfer ownership of 2012 Resort Class C license issued under the provisions of MCL 436.1531(2) and Specially Designated Merchant license with Sunday Sales Permit (P.M.) and Specific Purpose Permit (Food), from KNL, Inc., Stephen L. Langeland, Trustee. Commissioner Olshove supported, and the motion was carried by unanimous vote.

5. Saginaw Comedy, Inc., 220 Hamilton, Saginaw, Saginaw County  
Request ID# 306386

The licensing hearing was conducted for Saginaw Comedy, Inc., Request ID# 306386. Jason Geissler appeared on behalf of the Attorney Generals Office, sole stockholder Robert Paupore appeared on behalf of the licensee. Also present were Patricia Mosher and Daniel B. Ortiz. Mr. Geissler, Mr. Ortiz and Mr. Paupore offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated January 16, 2013, and to approve the request as set forth in the Licensing Appeal Order, for an extension of time beyond five (5) years escrow for 2012 Class C and Specially Designated Merchant licenses with Dance-Entertainment Permit, to December 31, 2013. Commissioner Olshove supported, and the motion was carried by unanimous vote.
