Chairman Deloney called the hearings to order at 10:05 a.m., noting a quorum was present.

- 1. Moved by Commissioner Weatherspoon, supported by Chairman Deloney, to approve the Lansing Appeal minutes from March 20, 2012, motion carried by unanimous vote.
- 2. Wac-N-Pac Corporation, d/b/a Alamo Food & Beverage, 6455 W D, Alamo, Alamo Township, Kalamazoo County Business ID# 10502

Navjinder Kaur Bath, 6455 W D, Kalamazoo, Alamo Township, Kalamazoo County Request ID# 616819

The show cause hearing was conducted for Wac-N-Pac Corporation, Business ID# 10502 and Navjinder Kaur Bath, Request ID# 616819. Jason Geissler appeared on behalf of the Attorney Generals Office, Attorney Kent Bieberich and Navjinder Kaur Bath appeared on behalf of the applicant. Mr. Geissler and Mr. Beiberich offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion that the Commission enter an order directing the Specially Designated Distributor and Specially Designated Merchant licenses with Sunday Sales Permit (P.M.) be placed in escrow until the parties to this transaction, Mr. William Campbell and Navjinder Kaur Bath, have resolved the issue on whether the purchase agreement between the parties included the subject liquor licenses, and the order will further state that the subject liquor licenses remain in escrow until the parties have presented the Commission with a resolution between the parties or a court order that determine who has rights to the licenses, supported by Commissioner Weatherspoon, and motion carried by unanimous vote.

3. Southtown Market, Inc., 15191 168th, Grand Haven, Grand Haven Township, Ottawa County Request ID# 562721

The church hearing was conducted for Southtown Market, Inc., Request ID# 562721. Jason Geissler appeared on behalf of the Attorney Generals Office, Wendy McGregor member and former Associate Pastor appeared for Grand Haven Church of the Nazarene, and Karen Leatherman, stockholder with store manager, Abby Przysucha, appeared on behalf of the licensee. Mr. Geissler, Ms. McGregor, Ms. Leatherman and Ms. Przysucha offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion that it be the finding of fact of the Commission that the Grand Haven Church of the Nazarene filed a proper objection to the granting of the Specially Designated Distributor license and that the applicant, Southtown Market, Inc., has demonstrated by showing competent, material evidence that the establishment would not provide a detrimental impact to the objecting church, and the application should proceed with no impediment, supported by Commissioner Weatherspoon, and motion carried by unanimous vote.

With no further business, moved by Commissioner Weatherspoon, supported by Chairman Deloney, that the Appeal Hearings be adjourned at 11:44 a.m., motion carried by unanimous vote.
