Commissioner Quimby called the hearings to order at 10:12 a.m., noting a quorum was present.

1. Moved by Commissioner Quimby, supported by Commissioner Olshove, that the minutes of the Lansing Appeal Hearings of April 9, 2013, be approved as written and presented, motion carried by unanimous vote.

2. Seth A. Brown, 2314 South 14th, Niles MI Request ID# 674581

The licensing hearing was conducted for Seth A. Brown, Request ID# 674581. Jason Geissler appeared on behalf of the Attorney Generals Office, Attorney Timothy Dowling and Seth A .Brown appeared on behalf of the applicant. Mr. Geissler, Mr. Dowling and Mr. Brown offered comments regarding this case. After discussion on the record, Commissioner Quimby made a motion to reverse the previous Commission Order of denial dated January 9, 2013, and to approve the request as set forth in the Licensing Appeal Order, for a new Salesperson License. Commissioner Olshove supported, and the motion was carried by unanimous vote.

3. Sullivans Mirror Lake Market Inc., 2450 S Lapeer, Lapeer, Lapeer Township, Lapeer County Request ID# 332456

The licensing hearing was conducted for Sullivans Mirror Lake Market Inc., Request ID# 332456. Jason Geissler appeared on behalf of the Attorney Generals Office, sole stockholder Jack Sullivan appeared on behalf of the licensee. Mr. Geissler and Mr. Sullivan offered comments regarding this case. After discussion on the record, Commissioner Quimby made a motion to reverse the previous Commission Order of

denial dated March 6, 2013, and to approve the request as set forth in the Licensing Appeal Order, for an extension of time beyond five (5) years escrow for 2012 Specially Designated Distributor and Specially Designated Merchant licenses with Sunday Sales (P.M.) and Living Quarters Permit, to April 30, 2014. Commissioner Olshove supported, and the motion was carried by unanimous vote.

4. Jeffrey's Acquisition, LLC, R 1, 12504 E D, Richland, Ross Township, Kalamazoo County Request ID# 668306

The licensing hearing was conducted for Jeffrey's Acquisition, LLC, Request ID# 623632. Jason Geissler appeared on behalf of the Attorney Generals Office, Attorney Mike Brown and applicant members, Scott Jeffrey and Jennifer Jeffrey appeared on behalf of the applicant. Mr. Geissler, Mr. Brown and Ms. Jeffrey offered comments regarding this case.

After discussion on the record, the hearing was recessed at 11:37 a.m.

The hearing reconvened at 11:48 a.m. Present were Commissioner Quimby and Commissioner Olshove, absent was Chairman Deloney.

After further discussion on the record, Commissioner Quimby made a motion to reverse the previous Commission Order of denial dated March 20, 2013, and remand the application back to the Licensing Division for further review as set forth in the Licensing Appeal Order. Commissioner Olshove supported, and the motion was carried by unanimous vote.

The hearings were recessed 11:55 a.m.

The hearings reconvened at 12:03 p.m. Present were Commissioner Quimby and Commissioner Olshove, absent was Chairman Deloney.

5. M & M 8 Mile 13109 Entertainment LLC, 13109 W Eight Mile, Detroit, Wayne County Request ID# 670811

The licensing hearing was conducted for M & M 8 Mile 13109 Entertainment LLC, Request ID# 670811. Jason Geissler appeared on behalf of the Attorney Generals Office, Attorney Frank J. Palazzolo and sole member Melissa A. Hashem, appeared on behalf of the applicant. Mr. Geissler and Mr. Palazzolo offered comments

regarding this case. After discussion on the record, Commissioner Quimby advised the matter would be tabled to a hearing at a future date, so the Commission could review the information presented at the hearing.

With no further business, moved by Commissioner Quimby, supported by Commissioner Olshove, that the Appeal Hearings be adjourned at 1:01 p.m., motion carried by unanimous vote.
