Chairman Deloney called the hearings to order at 10:20 a.m., noting a quorum was present. Due to a power outage at the Southfield District Office the meeting was conducted at the office next door, which is the United Center, 25700 W 8 Mile Road, Southfield, MI.

1. Moved by Commissioner Olshove, supported by Commissioner Quimby, that the minutes of the Southfield Appeal Hearing of April 18, 2013, be approved as written and presented, motion carried by unanimous vote.
2. The hearing for Sharky's Entertainment Group, LLC, Request ID# 516413, scheduled for today, has been cancelled at the request of the applicant.
3. The hearing for Vint, Inc. Request ID# 671283, scheduled for today, has been cancelled at the request of the applicant.
4. The hearing for ZMCC, Inc., Request ID# 516769, has been postponed at the request of the attorney for the applicant, due to the power outage at the Southfield District Office.
5. Hot Rocks Pizza, LLC, 1893 E. Big Beaver, Troy, Oakland County
Request ID# 662514

The show cause hearing was conducted for Hot Rock Pizza, LLC, Request ID# 662514, which was tabled from the hearings held on April 18, 2013. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office and Attorney Zachary Eskau appeared on behalf of licensee. Also present were MLCC Regional Supervisor Mary Ann Donley and MLCC Investigator Amy Jensen from the Southfield Enforcement Division. Ms. Pytel-McDowell and Mr. Eskau offered comments regarding this case. After discussion on the record, Chairman Deloney

advised that the Commission finds that the licensee has addressed the concerns that precipitated the hearing. Chairman Deloney made a motion that no further action will be taken against said licenses and permits at this time and the show cause hearing will be closed, as set forth in the Show Cause Hearing Order. Commissioner Olshove supported, and the motion was carried by unanimous vote.

6. Noor One, Inc., 8580 W. Nine Mile, Oak Park Oakland County
Request ID# 674904

The licensing hearing was conducted for Noor One, Inc., Request ID# 674904. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office, Attorney Joseph Shallal, Huda Sitta, President, appeared on behalf of the applicant. Also present were Kristen Redding, Mr. Shallal's assistant and Hatim Sitta, Mrs. Sitta husband. Ms. Pytel-McDowell, Mr. Shallal, Mrs. Sitta and Mr. Sitta offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated March 20, 2013, and approve the request as set forth in the Licensing Appeal Order, to transfer ownership of 2012 Specially Designated Distributor and Specially Designated Merchant licenses with Sunday Sales Permit (P.M.) from SBM Brothers, Inc. and a request for new Sunday Sales Permit (A.M.). Commissioner Quimby supported, and the motion was carried by unanimous vote.

With no further business, moved by Commissioner Olshove, supported by Commissioner Quimby, that the Appeal Hearings be adjourned at 10:43 a.m., motion carried by unanimous vote.
