Dawn Hetzel appeared on behalf of the Attorney Generals Office, Attorney Thomas Klug and trustee, Charlene K. Wilcox, appeared on behalf of the applicant. Also present was Mark O'Farrell, Investigator for the MLCC Enforcement Division. Ms. Hetzel, Mr. Klug and Mr. O'Farrell offered comments regarding this case. After discussion on the record, Chairman Deloney advised this matter would be tabled for a hearing on a future date, to allow the Commission time to review the submitted documents.

3. PCC Golf Course, LLC, 4901 Divine, Portland, Portland Township, Ionia County Request ID# 676754

The licensing hearing was conducted for PCC Golf Course, LLC, Request ID# 676754. Dawn Hetzel appeared on behalf of the Attorney Generals Office, Attorney James F. Mauro and applicant member Kristen Schrauben, appeared on behalf of

the applicant. Also present was Amy Mugnolo, Investigator for the MLCC Enforcement Division. Ms. Hetzel, Mr. Mauro, Ms. Schrauben and Ms. Mugnolo offered comments regarding this case. After further discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated April 29, 2013, and to approve the request for a new Class C and Specially Designated Merchant licenses and with the proviso that Marti J. Schrauben will not be involved in the operations of the business, as set forth in the Licensing Appeal Order. Commissioner Olshove supported, and the motion was carried by unanimous vote.
