Chairman Deloney called the hearings to order at 10:02 a.m., noting a quorum was present.

1. Moved by Commissioner Quimby, supported by Chairman Deloney, that the minutes of the Southfield Appeal Hearing of May 9, 2013, be approved as written and presented, motion carried by unanimous vote.
2. The hearing for Farmers Market, Inc., Request ID# 675774, scheduled for today, has been postponed.
3. Bella Piatti, LLC, 167 Townsend, Birmingham, Oakland County Request ID# 674895

The licensing hearing was conducted for Bella Piatti, LLC, Request ID# 674895. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney Kelly Allen, and Antonino Cutraro, applicant member, appeared on behalf of the licensee. Mr. Rosendo, Ms. Allen and Mr. Cutraro offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated May 1, 2013, and approve the request as set forth in the Licensing Appeal Order, to transfer membership interest in 2013 Class C license issued under the provisions of MCL 436.1521a(1)(b) and Specially Designated Merchant license, wherein Robert VanHelleMont transfer 50% membership interest to new member, Antonino Cutraro. Commissioner Quimby supported, and the motion was carried by unanimous vote.

Commission Order of denial dated April 17, 2013, and approve the request as set forth in the Licensing Appeal Order, to transfer ownership of 2012 Resort Class C license issued under the provisions of MCL 436.1531(2) and Specially Designated Merchant license with Sunday Sales Permit (P.M.) from New Seoul Garden, Inc. Commissioner Quimby supported, and the motion was carried by unanimous vote

5. Mariah Bar & Grill LLC, 15146 Gratiot, Detroit, Wayne County Request ID# 673500

Seven Mile, Detroit, Wayne County. Commissioner Quimby supported, and the motion was carried by unanimous vote.
