			(2) All motor vehicles, except MFSABs and school buses inspected by MSP, are inspected annually by a licensed mechanic. A copy of the inspection is kept on file at the center.  (3) Centers that use MFSABs and school buses do all of the following:		
			(a) Contact MSP to determine if an annual inspection by MSP is required by the Pupil Transportation Act.		
			(b) If directed by MSP, an annual inspection is conducted by MSP. A copy of the inspection is kept on file.		
			(4) A statement verifying that all motor vehicles, including volunteer vehicles, are in compliance with Michigan vehicle code		
			safety equipment requirements, is kept on file.		
			(5) Passenger vans with a rated seating capacity of 11 or more are not used.		
			(6) MFSABs used for transporting children to and from school comply with all minimum safety specifications, except color, identification, and alternating flashing lights.		
			(7) Motor vehicle seats used by children, staff, and volunteers do not face sideways.		
			(8) Only the cab of a truck is used to transport children.		
			(9) There are no loose or heavy objects in the passenger compartment of any motor vehicle.

			<ul><li>(1) All motor vehicles carry the following safety equipment:</li><li>(a) Three bi-directional emergency reflective triangles properly cased and securely stored in the vehicle.</li></ul>		
			(a) Three bi-directional emergency reflective triangles properly cased and securely stored in the vehicle.  (b) A first aid kit is securely stored in an accessible location in the driver compartment.		
_	_	_	(2) Any motor vehicle with a seating capacity of more than 10 carry the following additional safety equipment:		
			(a) Not less than 3 15-minute fuses (flares) or an approved battery operated substitute properly cased and securely

			(1) Each child remains seated and properly restrained by a passenger restraint while the vehicle is in motion.		
			(2) Restraint devices are not required on school buses or MFSABs.		
			(3) Each restraint device is properly anchored and used according to the manufacturer's specifications. Two or more		
			children are not allowed to share a seat belt or restraint device.  (4) The driver and all adult passengers are seated according to the seating capacity and properly restrained when the		
			vehicle is in motion.

			(e) Is familiar with the contents of the first aid kit.		
			(f) Is familiar with the operation of the fire extinguisher, if required.		
			(2) The following documents are on file in the center:		
			(a) A copy of each driver's driving record, obtained from the Secretary of State at least once a year.		
			(b) A self-certifying statement that all volunteer drivers comply with subrule (1).		
			(c) A copy of a valid driver's license.		
			(3) Drivers have a copy of the Child Information Card for each child being transported in their vehicles.

			(1) The ratio of staff/volunteers-to-children:  (a) Infants and toddlers, 1:4, excluding the driver.
