SETTLEMENT AGREEMENT

In The Matter Of:
Patricia Gonzales LLC
Registration #: DC250358847

On August 14, 2015, the Bureau of Community and Health Systems issued a *Notice of Intent To Revoke* the child care center license of Patricia Gonzales LLC.

In settlement of all issues raised in the *Notice of Intent To Revoke*, the undersigned parties hereby agree:

- 1) Patricia Gonzales LLC neither admits nor denies the allegations set forth in the *Notice of Intent To Revoke*; however, Patricia Gonzales LLC admits to a violation of the Child Care Organizations Act and/or a licensing rule promulgated under the Act.
- 2) Patricia Gonzales LLC understands its child care center license will be revoked and agrees to cease providing care to unrelated children at the licensed center, effective September 23, 2015.
- 3) Patricia Gonzales LLC agrees to withdraw the appeal to the *Notice of Intent To Revoke* the license and understands that an administrative hearing will not be held in this matter.
- 4) Patricia Gonzales LLC agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organizations Act for a period of two years from the effective date of this agreement.
- 5) This agreement does not prohibit Licensee Designee Patricia Gonzales from working in a licensed child care home or center so long as the home or center is not at her place of residence, and the position at the facility is not one of registrant, licensee, licensee designee, program director, or administrator.

6) Patricia Gonzales LLC understands that under MCL 722.125, Section 15(1), a person who provides child care without a license or certificate of registration is guilty of a misdemeanor, and the offense is punishable by up to 90 days imprisonment and/or a \$1,000 fine.
