On July 10, 2015, the Bureau of Community and Health Systems issued a *Notice of Intent to Refuse to Renew* the child care center license of Country Corner Day Care, Inc.

In settlement of all issues raised in that *Notice of Intent to Refuse to Renew*, the undersigned parties hereby agree:

- 1) Country Corner Day Care, Inc neither admits nor denies that the specific allegations set forth in the *Notice of Intent to Refuse to Renew* are true, but agrees that at least one violation of the Child Care Organizations Act, 1973 PA 116, has occurred.
- 2) Country Corner Day Care, Inc understands that their child care center license will be administratively closed, effective 30 days of the date of signature by the representative of the Bureau of Community and Health Systems.
- 3) Country Corner Day Care, Inc understands that they are waiving their right to appeal the *Notice of Intent to Refuse to Renew*, and an administrative hearing will not be held in this matter.
- 4) Country Corner Day Care, Inc agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organization Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
