




NOW THEREFORE, IT IS ORDERED pursuant to authority delegated by the Department Director that the above-captioned matter is hereby **DISMISSED**.



On July 1, 2015 the Bureau of Community and Health Systems issued an *Amended Notice of Intent to Refuse to Renew* the certificate of registration to operate a family child care home of Amy Holden, Registrant.

In settlement of all issues raised in that *Notice of Intent to Refuse to Renew*, the undersigned parties hereby agree:


- 1) Amy Holden neither admits nor denies that the specific allegations set forth in the *Notice of Intent to Refuse to Renew* are true, but agrees that at least one violation of the Child Care Organizations Act, 1973 PA 116, has occurred.
- 2) Amy Holden understands that her certificate of registration will not be renewed, effective the date of signature by the representative of the Bureau of Community and Health Systems.
- 3) Amy Holden understands that she is waiving her right to appeal the *Notice of Intent to Refuse to Renew* and a hearing will not be held in this matter.
- 4) Amy Holden agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organization Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
