
SETTLEMENT AGREEMENT


On July 7, 2015, the Office of Child and Adult Licensing issued an *Order of Summary Suspension and Notice of Intent to Revoke* the family child care home certificate of registration of Rachel Bissell.

In settlement of all issues raised in the *Order of Summary Suspension and Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Rachel Bissell neither admits nor denies the allegations set forth in the *Order of Summary Suspension and Notice of Intent to Revoke*; however, Ms. Bissell admits to a violation of the Child Care Organizations Act and/or a licensing rule promulgated under the Act.
- 2) Rachel Bissell understands that her family child care home certificate of registration will be revoked, effective the date of the signature by the representative of the Office of Child and Adult Licensing. Ms. Bissell agrees to immediately cease providing care to unrelated children in her home.
- 3) Rachel Bissell understands that under MCL 722.125, Section 15(1), a person who provides child care without a license or certificate of registration is guilty of a misdemeanor, and the offense is punishable by up to 90 days imprisonment and/or a \$1,000 fine.
- 4) Rachel Bissell understands that she is waiving her right to appeal the *Order of Summary Suspension and Notice of Intent to Revoke* her certificate of registration, and an administrative hearing will not be held in this matter.
- 5) Rachel Bissell agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organizations Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
