SETTLEMENT AGREEMENT

**In The Matter Of:**  
**Courtney Prill**

On November 18, 2015, the Bureau of Community and Health Systems issued an *Order of Summary Suspension and Notice of Intent To Revoke* the family child care home certificate of registration of Courtney Prill.

In settlement of all issues raised in the *Order of Summary Suspension and Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Courtney Prill does not contest the allegations set forth in the *Order of Summary Suspension and Notice of Intent To Revoke* and agrees that the Bureau may treat the allegations of fact and law as true, which finding shall have the same force and effect for purposes of this Agreement as if evidence and argument were presented in support of the allegations.
- 2) Courtney Prill is not admitting the truth of the allegations but is agreeing that the Bureau may treat the allegations as true for purposes of resolution of the *Order of Summary Suspension and Notice of Intent To Revoke*, and any future administrative or disciplinary matter concerning Courtney Prill's certificate of registration.
- 3) Courtney Prill understands that her family child care home certificate of registration will be revoked, effective the date of the signature by the representative of the Bureau of Community and Health Systems. Ms. Prill agrees to immediately cease providing care to unrelated children in her home.
- 4) Courtney Prill understands that under MCL 722.125, Section 15(1), a person who provides child care without a license or certificate of registration is guilty of a misdemeanor, and the offense is punishable by up to 90 days imprisonment and/or a \$1,000 fine.
- 5) Courtney Prill understands that she is waiving her right to appeal the *Order of Summary Suspension and Notice of Intent To Revoke* her certificate of registration, and an administrative hearing will not be held in this matter.

5) Courtney Prill understands that under MCL 722 121(5), "(t)he department shall not issue or renew a license or certificate of registration of a child care center, group child care home, or family child care home if the licensee, registrant, or applicant has had a previous license or certificate of registration revoked due to a violation of this act, the rules promulgated under this act, or the terms of the license or certificate of registration that resulted in the serious injury or death of a child while under its care."
