
NOW THEREFORE, IT IS ORDERED that the Settlement Agreement dated October 15, 2015 is hereby approved.



The Michigan Administrative Hearing System has removed this case from its docket, cancelled the continued hearing scheduled for December 1, 2015, and closed its file in this matter.


The Settlement Agreement is attached hereto, incorporated by reference into this Order, and transmitted to the Director of the Department of Licensing and Regulatory Affairs.

On September 24, 2015 the Bureau of Community and Health Systems issued an Order of Summary Suspension and Notice of Intent to Revoke the certificate of registration to operate a family child care home of Anita Tillman, Registrant.

In settlement of all issues raised in that Order of Summary Suspension and Notice of Intent to Revoke, the undersigned parties hereby agree:

- 1) Anita Tillman neither admits nor denies that the specific allegations set forth in the Order of Summary Suspension and Notice of Intent to Revoke are true, but agrees that at least one violation of the Child Care Organizations Act, 1973 PA 116, has occurred.
- 2) Anita Tillman understands that her certificate of registration will be revoked, effective the date of signature by the representative of the Bureau of Community and Health Systems.
- 3) Anita Tillman understands that she is waiving her right to appeal the Order of Summary Suspension and Notice of Intent to Revoke and a hearing will not be held in this matter.
- 4) Anita Tillman agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organization Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
