SETTLEMENT AGREEMENT



On November 17, 2015, the Bureau of Community and Health Systems issued an *Order of Summary Suspension and Notice of Intent to Revoke* the group child care home license of Julie Bakeman.

In settlement of all issues raised in the *Order of Summary Suspension and Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Julie Bakeman neither admits nor denies the allegations set forth in the *Order of Summary Suspension and Notice of Intent to Revoke*; however, Julie Bakeman admits to a violation of the Child Care Organizations Act or a licensing rule promulgated under the Act.
- 2) Julie Bakeman understands that her group child care home license will be revoked, effective the date of the signature by the representative of the Bureau of Community and Health Systems.
- 3) Julie Bakeman understands that it is unlawful to provide child care without a license. Julie Bakeman agrees to immediately cease providing care to unrelated children in her home.
- 4) Julie Bakeman understands that she is waiving her right to appeal the *Order of Summary Suspension and Amended Notice of Intent to Revoke* her license, and an administrative hearing will not be held in this matter.
- 5) Julie Bakeman agrees not to apply for a license or certificate of registration for a child care organization licensed or registered under the Child Care Organizations Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
