

On June 8, 2015, Kristin M. Heyse, Assistant Attorney General on behalf of Respondent, submitted a Settlement Agreement executed by the parties on May 28, 2015 and June 8, 2015. The Settlement Agreement resolves all of the allegations contained in the Order of Summary Suspension and Notice of Intent to Revoke License dated January 26, 2015, and served on January 27, 2015.

The Michigan Administrative Hearing System has removed this case from its docket, cancelled the hearing on June 1, 2015, and closed its file in this matter.

SETTLEMENT AGREEMENT

In The Matter Of:  
Tabitha Gordon

On January 27, 2016, the Bureau of Children and Adult Licensing issued an *Order of Summary Suspension and Notice of Intent to Revoke* the group child care home license of Tabitha Gordon.

In settlement of all issues raised in the *Order of Summary Suspension and Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Tabitha Gordon neither admits nor denies the allegations set forth in the *Order of Summary Suspension and Notice of Intent to Revoke*; however, Ms. Gordon admits to a violation of the Child Care Organizations Act or a licensing rule promulgated under the Act.
- 2) Tabitha Gordon understands that her group child care home license will be revoked, effective the date of the signature by the representative of the Bureau of Children and Adult Licensing. Ms. Gordon agrees to immediately cease providing care to unrelated children in her home.
- 3) Tabitha Gordon understands that under MCL 722.125, Section 15(1), a person who provides child care without a license is guilty of a misdemeanor and punishable by up to 90 days imprisonment and/or a \$1,000 fine.
- 4) Tabitha Gordon understands that she is waiving her right to appeal the *Order of Summary Suspension and Notice of Intent to Revoke* her license, and an administrative hearing will not be held in this matter.

5) Tabitha Gordon agrees not to apply for a license or certificate of registration for a child care organization licensed or registered under the Child Care Organizations Act for a period of five years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
