CONSENT ORDER AND STIPULATION

A. FINDING OF FACTS AND CONCLUSIONS OF LAW

It is alleged that the following statements are true and correct:

1. Pursuant to MCL 500.1247(2), Daniel Patrick Gallagher (Respondent) reported to the Office of Financial and Insurance Regulation (OFIR) that he was charged with four counts of Criminal Sexual Conduct 1<sup>st</sup> Degree involving a person less than 13 years of age. The complaint in the criminal matter was subsequently amended to include two counts of criminal sexual conduct second degree.
2. Respondent pled guilty to two counts of Criminal Sexual Conduct 2<sup>nd</sup> Degree and the four counts of Criminal Sexual Conduct 1<sup>st</sup> Degree were dismissed.
3. On October 4, 2010, the Court sentenced Respondent to 3 years probation along with other conditions outlined in the Judgment of Sentence Commitment to Jail (JSCJ), and ordered Respondent to pay restitution, fees and other costs.
4. As a licensee, Respondent knew or had reason to know that Section 1239(1)(f) of the Code, MCL 500.1239(1)(f), allows the Commissioner to place on probation, suspend, revoke, or levy a civil fine under Section 1244 or any combination thereof, for "Having been convicted of a felony."
5. Based upon the actions listed above, Respondent has committed acts that are grounds for the Commissioner ordering payment of a civil fine and/or licensing sanctions under Section 1244(1) of the Code for the Respondent's violation of Sections 1239(1)(f) of the Code.

**B. ORDER**

Based upon the findings of fact and conclusions of law above, and Respondent's stipulation to said facts, it is hereby ORDERED that:


1. Respondent Gallagher's insurance producer license and authority are hereby **REVOKED**.


**C. STIPULATION**
