SUBJECT: Allocation from Joint Fire Service Expo

The 2021 Joint Fire Service Expo has been cancelled by a vote of the Joint Council on January 8, 2021. There was \$80,000 that was allocated for the 2021 Joint Fire Service Expo in Novi prior to the disbursement of the initial county funds on October 1, 2020 by the Michigan Fire Fighter Training Council (MFFTC).

Due to the Joint Fire Service Expo being cancelled, we will be re-disbursing the \$80,000 to the 26 counties that received more than the minimum of \$17,500 for each county, using the formula to disburse the county funds based on square miles and population.

Attached is a spreadsheet showing the funding being returned to each of those 26 counties due to the cancelling of the 2021 Joint Fire Service Expo.

Each county will have until February 28, 2021 to encumber these returned funds. If the funds are not encumbered, the funds will be pulled back and applied to the funds the MFFTC approved to be used for mental health training through September 30, 2021.
