FINAL DECISION OF THE ELECTRICAL ADMINISTRATIVE BOARD

On February 11, 2021, the Electrical Administrative Board reviewed Mr. Demond King's appeal of denial of his Application for Master Electrician Examination, dated November 14, 2020 and all supplemental materials. This decision is issued pursuant to Section 339.5319 of 2016 PA 407.

FINDINGS AND CONCLUSIONS: The Board acknowledged receipt and reviewed the material on this matter at the meeting on the above noted date. Mr. King was not present at the Board Meeting at the time his application was reviewed. Following discussion, the Board moved to deny Mr. King's appeal to sit for the Master Electrical Examination as he did not provide adequate documentation showing that he met the requirements.

THEREFORE, it is the order of the Board to deny Mr. King to sit for the Master Electrician Examination due to not meeting the requirements set forth in Article 7, Section 339.5713 of PA 407, The Skilled Trades Regulation Act. You have the right to request a judicial review of this decision in accordance with the Administrative Procedures Act, 1969 PA 306.

FINAL DECISION OF THE ELECTRICAL ADMINISTRATIVE BOARD

On February 11, 2021, the Electrical Administrative Board reviewed Mr. Christopher Kniffen's appeal of denial of his Application for Journeyman Electrician Examination, dated October 27, 2020 and all supplemental materials. This decision is issued pursuant to Section 339.5319 of 2016 PA 407.

FINDINGS AND CONCLUSIONS: The Board acknowledged receipt and reviewed the material on this matter at the meeting on the above noted date. Mr. Kniffen did appear at the meeting. Following discussion, the Board moved to deny Mr. Kniffen's appeal due to failure to provide the required notarized documents clearly indicating the hours of experience were related to electrical construction or maintenance of buildings or electrical wiring or equipment and under the direct supervision of an individual who is licensed under Article 7 of PA 407. The Board reminded Mr. Kniffen that he does have one year from the date of the application to meet the requirements for licensure.

THEREFORE, it is the order of the Board to deny Mr. Christopher Kniffen to sit for the Journeyman Electrician Examination due to not meeting the requirements of MCLs 339.5709(a) and 339.5715(1). You have the right to request a judicial review of this decision in accordance with the Administrative Procedures Act, 1969 PA 306.
